### DONOR ADVISED FUNDS

A simple, flexible and tax savvy way for a donor to give to their favorite charities



A Donor Advised Fund (DAF) is a great way to turn highly appreciated securities, like stocks or non-cash assets, into funds committed to a charitable purpose. A donor's tax deduction is maximized, capital gains payments are minimized and nonprofits benefit from the direct financial support of local philanthropy.

#### Who it's for:

Individuals, families and businesses. A DAF is a great tool for a donor to organize charitable giving with just one tax receipt and make a commitment to supporting the causes they care about.

#### How it works:

A donor gifts cash, stocks, cryptocurrency or noncash assets and receives a tax deduction immediately upon contribution.

The assets are invested and may grow tax free over time.

The donor makes grant recommendations to any 501(c)(3) charitable organization when the time is right.

# ADDITIONAL CHARITABLE GIVING TOOLS

There are a number of additional charitable giving tools that Beauport can help you leverage to maximize your philanthropy and work with your overall wealth plan.

#### Life Insurance

Life insurance can be an effective and convenient asset to gift to charity. Not only can the gift of life insurance greatly reduce your taxable estate, but it can also provide a meaningful opportunity for you to multiply your generosity and have a significant philanthropic impact on nonprofits you care about.

#### Qualified Charitable Distribution from an IRA

A Qualified Charitable Distribution (QCD) is a distribution from an individual retirement account (IRA) made directly to an eligible 501(c)(3), bypassing the owner of the account. If you are an owner of an IRA who is at least age 70 ½, you can contribute up to \$100,000 a year from your IRA to charity. This is an effective way to increase your charitable impact, satisfy your required minimum distribution (RMD) for the year and reduce your adjusted gross income (AGI).



## The Beauport Financial Richard D. Wilson Community Response Gift Fund

A Donor Advised Fund (DAF) of Essex County Community Foundation (ECCF)

Gloucester resident and philanthropist Dick Wilson has spent a lifetime doing big things for his community – and inspiring others to do the same. A longtime mentor to the Beauport Financial Services (BFS) team, Wilson's quiet and steady philanthropy has been foundational to the firm's own commitment to giving back in its many forms.

Now, through the fund named after Wilson, BFS reinvests 10 percent of its annual net profits into local (and several international) communities.

In 2022, the firm's collective giving through The Beauport Financial Richard D. Wilson Community Response Gift Fund surpassed \$1 million.

#### How Collective Giving at Beauport Financial Services Works:

Each fall, Beauport Financial Services clients and staff members are invited to submit grant proposals on behalf of a favorite nonprofit or charitable cause.

Grant applications are thoughtfully reviewed by committee.

Grantees – all tax-exempt 501(c)(3) organizations – are officially announced and celebrated at Beauport Financial's annual holiday party.

As the DAF sponsor, ECCF handles the administrative work of the grant process.



Here are a few highlights of the many nonprofits we support through the Beauport Financial Richard D. Wilson Community Response Gift Fund.

#### THE OPEN DOOR, Gloucester, MA

#### Nominated by Beauport Clients

Food insecurity continues to become a reality for more and more people, particularly in the post-COVID era of skyrocketing food prices.

"Who hasn't walked out of the grocery store recently reeling from the cost of buying groceries? For those who are on the cusp financially, it has been devastating," Julie LaFontaine, President and CEO of The Open Door, said recently.

Founded in 1983, The Open Door works to alleviate the impact of hunger across Cape Ann by using practical strategies to connect people to good food, advocate on behalf of those in need and engage others in the work of building food security.

Through a variety of innovative food security programs, including Model Food Pantry, mobile markets, on-site SNAP application assistance and medically tailored food choices, The Open Door served 8,486 people and 4,872 households in 2022. The organization distributed 1.78 million pounds of food, 29% of which was fresh produce.

## PATHWAYS FOR CHILDREN, Gloucester, MA

Nominated by Derek and Karen Reed

Pathways for Children nurtures children and supports families impacted by economic and social inequity through educational programming for kids, a supportive network for caregivers, professional development initiatives designed to inspire the next generation of teachers and youth and family service workers, and holistic support for families.

Beginning with Head Start preschool programming on Cape Ann in 1967, Pathways has blossomed into a robust social services organization that serves 2,500 people every single year. From playgroups, parenting classes and support groups to internship and apprenticeship opportunities for teachers, Pathways offers critical services to people in Essex County communities who need it most. Of the people they serve, 77% live below the federal poverty level and 11% experience homelessness in a year.



## YMCA OF THE NORTH SHORE

#### Nominated by David and Elaine McKechnie

Childcare. Sports and camps. Affordable housing. Leadership development. Swimming and exercise programming. Support services for newcomers and immigrants. Advocacy. These are just some of the programs and services the **YMCA of the North Shore** offers local residents.

Centered on community, the YMCA of the North Shore – comprised of seven local Y's, including the Cape Ann and Beverly locations – works side-by-side with their neighbors to make sure that everyone, regardless of age, income or background, has the opportunity to learn, grow and thrive.


With focuses on youth development, healthy living and social responsibility, there's almost no community challenge that the work of the Y doesn't touch.



## WELLSPRING, Gloucester, MA Nominated by Beauport Financial Clients

Thousands of individuals and families each year find support and critical resources at Wellspring, a Gloucester-based nonprofit that inspires families and adults on the North Shore to achieve employment and financial security through stable housing, education, job training and career readiness.

In 2022 alone, nearly 2,000 families and individuals looked to **Wellspring** for opportunities to better their lives. Of those, **450** individuals did intensive work to secure permanent housing, living wage jobs, English proficiency and more.



### ARISE RWANDA

## Nominated by the Beauport Financial Team and Valmark Securities, Beauport's Business Partner

In Boneza, a community of 26,000 people in the Western Provence of Rwanda, Kivu Hills Academy sits high above the waters of Lake Kivu. Its halls and classrooms are bustling with teenaged students who, prior to the school's construction in 2015, couldn't even imagine the possibility of a secondary education.

"There was no hope in this community for the kids to go to high school," said John Gasangwa, founder of Arise Rwanda, a nonprofit organization coordinating critical infrastructure projects in Boneza, including the school. "There was no high school for 26,000 people."

Schooling in Boneza ended at grade 8. But today, 300 students are receiving a high school education and gaining technical skills that will prepare them for successful careers in a variety of industries, including the trades, computer sciences and tourism and hospitality.

"These kids now have a very, very bright future ahead of them with some great skills that they are learning," said David McKechnie, who has traveled to Rwanda several times with family and colleagues.

Kivu Hills Academy is one of several Arise Rwanda infrastructure projects supported by the Beauport Financial Services team through the firm's charitable fund. Others include several wells for clean water and the only medical facility, which is currently under construction and will serve over one million people in both Rwanda and Congo.
